The Board of Directors of Basic Energy Corporation (BEC), in its regular board meeting held on November 27, 2013, approved a P278 million budget expenditures program for 2014. The program covers the company's oil and energy development projects both here and abroad.

Substantial portions of the budget will fund the company's investment in an ongoing on-shore oil drilling project in Java, Indonesia and in the Mabini, Batangas Geothermal Energy project. P104 million has been allocated to the Indonesia oil project, where the drilling of two (2) wells located in proven oil fields is on-going. The drilling of an additional eight (8) oil wells has been planned for next year.

P98 million has been allocated for work on the Mabini, Batangas Geothermal Project. The Department of Energy had earlier approved a two-year term extension until July, 2015, for BEC and its partners to undertake the drilling of one (1) exploratory well. With the pre-feasibility study already complete, BEC is now mobilizing potential contractors to drill the exploratory well at an estimated total cost of US\$4 million.

P20-million has been allocated also for an investment in an on-shore oil well drilling project in Mindoro Island, for the company's share in the drilling costs of one (1) exploratory well.

The other budget items will fund development works in the geothermal projects in Mariveles, Bataan; East Mankayan in Benguet; and Mt. Iriga in Camarines Sur, and another area expected to be awarded to BEC by year-end, permitting and feasibility studies for certain mini-hydro power projects, and additional operating expenses for project management personnel and for technical capability enhancement.
