The Board of Directors of Basic Energy Corporation (the Company), in its Regular Board Board meeting on December 15, 2021, at which a quorum was present, and upon motion duly seconded, unanimously took note of and/or approved the following:

- 1. Issuance of the corresponding stock certificate and the filing of the listing application of the 9,827,990,853 shares of Map 2000 Development Corporation (M2DC) based on the update that the subscription balance was received by BSC on December 10. 2021;
- 2. Execution of the Subscription Agreement between BSC and Filoil Energy Company, Inc. (FEC) on December 7, 2021 and the consummation of BSC's subscription and payment of the subscription price to FEC on December 10, 2021 for which the required Advisement Report was submitted to the Securities and Exchange Commission (SEC) and the PSE on the same day. The Management also clarified to the Board the reason for the mandatory trading halt/suspension brought about by the disclosure of the said material transaction/information per PSE Listing and Disclosure Rules, and which should be lifted as soon as all the required reports and information are submitted to PSE.
- 3. Nomination and election of Mr. Ramon F. Villavicencio as a Director of BSC upon recommendation of the Nomination Committee
- 4. Nomination and election of Mr. Ramon F. Villavicencio as Chairman of the Board of Basic Energy Corporation
