Mabini Wind Energy Project; Material Development/Update; Basic Energy Corporation (BSC) and RENOVA Inc. Signs Memorandum of Understanding Signifying Positive Direction Towards Mabini Wind Energy Project Partnership

1 February 2024, Mandaluyong City, Philippines –Basic Energy Corporation signed the Memorandum of Understanding (MOU) with RENOVA Inc. (RENOVA) in relation to the Mabini Wind Energy Project located at Mabini, Batangas. This comes after the Board of BSC gave its approval for Management to sign the MOU last January 29, 2024.

The signing of the MOU is the initial and definitive step of the parties towards the signing of a Joint Development and Shareholders Agreement (JDSHA) with RENOVA signifying and cementing its partnership with BSC (through its wholly owned subsidiary Mabini Energy Corporation (MEC) as the Special Purpose Company/Vehicle) in the Mabini Wind Energy Project. The MOU signing comes after RENOVA saw the potential viability of the project based on its initial and on-going due diligence review of the data gathered from the met mast installed in the project area as well as those gathered from the LIDAR system procured MEC back in 2023.

The scheduled signing of the subsequent definitive agreement(s) like the JDSHA is set to be finalized by the end of the first quarter of this year. With the signing of the MOU, the Parties declare their joint commitment to the development of the onshore wind power project pursuant to the JDSHA, symbolizing a significant stride in sustainable energy initiatives being promoted by the country.

RENOVA Inc., is a Japanese publicly listed company that was incorporated on 30 May 2000. RENOVA is known to be one of the leading companies in the growing renewable energy market of Japan. It is Japan's publicly traded independent pure-play developer and power producer that is exclusively focused on renewable energy projects and development in the Asia-Pacific Region. In its more than 20 years of existence RENOVA has ventured into numerous power generation and renewable energy projects both in Japan and in other countries. Among RENOVA's notable foreign renewable energy project tie-up are its participation in Onshore Wind Projects in Quang Tri Province in Vietnam as well as another renewable energy project in the Philippines.

About the Mabini Wind Energy Project

The Mabini Wind Energy Project (the "Project") is covered by Wind Energy Service Contract (WESC; WESC No. 2021-01-142) issued by the Department of Energy (DOE) as disclosed by BSC on March 24, 2021 (PSE Company Disclosure Ref. No. C01909-2021). The service contract has a land coverage area of 4,860 hectares in the Mabini Peninsula with a potential capacity of 50 MW. It is expected to operate and deliver power to the grid by 2027.

The Project is being undertaken by Mabini Energy Corporation (MEC), a wholly owned unit of Basic Energy Corporation. To date, MEC continues to conduct its wind resource assessment for the project by collecting the data from LIDAR equipment readings and the meteorological mast installed in the project area.
