BASIC ENERGY SIGNS MEMORANDUM OF UNDERSTANDING WITH PANGASINAN 1 ELECTRIC COOPERATIVE (PANELCO 1) TO CONDUCT DISTRIBUTION IMPACT STUDY & DISTRIBUTION ASSET STUDY IN RELATION TO ITS PROSPECTIVE SOLAR POWER PROJECT IN PROVINCE OF PANGASINAN

1 February 2024, Mandaluyong City – Basic Energy Corporation ("BSC") is developing a potential 50MW Solar Power Project inclusive of a Battery Energy Storage System ("BESS") in the province of Pangasinan. The planned solar power project will come in two phases with 10MW plus BESS intended to be developed and constructed as Phase 1 of the solar project. Phase 2, with a capacity of around 40MW, will then follow.

In line with the planned development of the project, BSC has signed a Memorandum of Understanding ("MOU") with Pangasinan 1 Electric Cooperative ("PANELCO I") on January 30, 2024. The MOU is a collaboration between BSC and PANELCO I to conduct Distribution Impact Study ("DIS") and Distribution Asset Study ("DAS") on the PANELCO I distribution facilities.

The DIS and DAS are integral to optimize distribution networks and enhance reliability of PANELCO I's current infrastructure. Furthermore, the DIS and DAS also ensures seamless integration of renewable energy resources into PANELCO I's infrastructure, integral to BSC's solar power project within the service area of PANELCO I.

Understanding the complexity of such integration, the DIS and DAS are deemed necessary. These studies, to be conducted in collaboration with PANELCO I, have a twofold purpose. Firstly, to assess the compatibility of PANELCO I's transmission system and sub-stations to accommodate the solar power plant's production. Secondly, to gain insights into the current state of the transmission system, identifying requisite improvements for optimal performance aligned with the solar power plant's energy production.

With the signing of the MOU, BSC and PANELCO I reached a significant milestone in their shared commitment to provide clean and reliable energy to the province and beyond.
